3. BREAZE's New Energy Jobs Funding Application	<p>Ian reported that BREAZE, City of Ballarat, Federation University and Committee for Ballarat representatives attended the New Energy Jobs Round 2 information session held by DELWP, SV and Regional Development Victoria in January. It was evident that no other parties were working on a Biomass project. BREAZE is preparing an application for Business Case Funding of a Ballarat Biomass Briquette Supply Chain. Ian circulated the staged concept plan (attached) for the proposal that involves utilising sawdust from Ballarat Regional Industries and Fed Uni Trade Centre to create briquettes that would be used for Biomass heating at BRI, Potentially PINARC and potentially sold to retail outlets. Applications close on 1 March 2017 and BREAZE is committing \$2,500 cash and \$75,000 in kind to the project. 4. Principles of Responsible Management Presentation Federation University	<p>Craig Hurley provided a handout and made a verbal presentation on the School of Business PRME program that applies to all undergraduate and post graduate business management courses. The presentation included information on the PRME international forum held by Fed Uni last year. The presentation included results of surveys conducted internationally of students, with key findings that:</p> <ul style="list-style-type: none"> • Majority of students thought the PRME program was beneficial to their careers • Majority would want to work in organisations that demonstrated alignment with the PRME goals • Audit of courses against the 17 UN Sustainable development Goals. <p>Questions raised revealed:</p> <ul style="list-style-type: none"> • Dale Boucher Fed Uni's Sustainability officer produces reports on operations sustainability impacts. • Fed Uni are working with Commerce Ballarat to try and bring these criteria into environmental sustainability rankings in the Ballarat Business Awards 	Craig to send link or email PDF of the presentation handout.
5. BREAZE Expressions of Interest for Project and Event Managers	Ian reported that BREAZE advertised expressions of interest in December via the Courier, Seek and Members Newsletter for suitable contractors to undertake project and event management for the next 2 years. The Board has approved a number of contractors who met the criteria to form a panel which would be approached to undertake event management and/ or project management to deliver services in response to any funded projects and programs.	
6. Proposed Bioenergy Event	<p>Ian presented a concept for RSAB to deliver a Ballarat Regional Bioenergy Event later in the first half of 2017. Given the number of events in Ballarat and Melbourne in coming days on community renewable energy and waste to energy, it was considered an event that focussed on integrating Bioenergy with other renewable energies could attract representatives of institutions from the health, education, local government water and disability services sectors to hear about how other organisations have integrated Bioenergy into their energy mix.</p> <p>Ideas suggested for tailoring the event included:</p> <ul style="list-style-type: none"> • If the majority of energy consumed is in residential properties, then why are we putting so much effort into convincing non residential properties to convert to renewable energy? • It was suggested that in order to get commitment from organisations, that a breakfast meeting for senior decision makers would first be necessary to create the commitment to sending appropriate technical people to the whole day event. • Could we use the Hospital Precinct, Ballarat Aquatic Centre, Civic Hall Precinct as hypothetical sites to workshop solutions? • VBN and Cultivate Agribusiness could not attend today, however have conveyed that their preference would be to conduct the next Bioenergy event in northern Victoria, considering the lack of enthusiasm displayed after Liz Hamilton's presentation last year.
