

| 4. | City of Ballarat Workshop Activity | Ian handed over to Cameron Duthie and Mary Maddock to facilitate the workshop activity Preparing for the Council Plan 2017-2021. The findings have been formatted into a separate PDF document entitled "Council Plan Consultation 2017-2021 Waste and Environment". | | | |
| 5. | Potential RSAB Renewable Energy Forum | Ian presented the concept of a potential RSAB Renewable Energy Forum comprising: Case Studies – e.g. Hepburn Wind, Central Victoria Solar Cities, Renewable Newstead, Beaufort Hospital, Berrybank Farm, Social Solar by BREAZE. Project Development – e.g. Biomass Heating, Methane capture and re-use, wind micro-turbines, biofuels Members suggested it also include: The CSIRO case study of Stockland's HVAC (Heating Ventilation and Air Conditioning) system Consider running the event at Ballarat Mercure to coincide with an event being arranged by the Premiers Department and Committee for Ballarat. Date to be advised later. This would allow a community event to follow on from an invitation only high profile event. The event could be used to develop some conceptual renewable energy projects with partners for consideration in future funding programs. | Members to liaise with Ian to determine date, scope, audience and content. | | |
| 6. | Information Sharing | Andrew has recently visited a number of sites in Lithuania and Finland where bioenergy has been employed to provide renewable energy. (Andrew to send information for newsletter). Belinda reported that City of Ballarat are considering a report on signing the Take2 pledge and the Clean Green Advisory Committee has been appointed and will hear a report from Andrew Lang. Belinda reported that CVGA has developed a simplified standardised reporting framework for local government agencies to report greenhouse gas emissions and have developed a low income solar scheme potentially for state-wide application. Jeff reported that the Canadian State Park was declared on 5th August and a Wathaurang name is being adopted "Woowookarung Regional Park" meaning "place of plenty". Parks Victoria have distributed 4,000 information kits to surrounding residents and interest groups. PV are developing a management plan trialling a model of community management group and engagement strategy. Andrea reported that the Friends of Royal Park are focussing on the delivery of the Sustainable Living Expo in February. She reported that the Leigh Catchment Group was busy with the final stages of the Yarrowee Project and seeking support funding to continue engagement programs for the Yarrowee. Significant LCG resources have been directed to environmental recovery actions following the Scotsburn Fires and after lobbying Vic Govt. a grant has been made to | | | |

Cluster groups are now meeting through till November. Ross Gillett (DELWP) indicated that Daylesford Neighbourhood House is seeking a facilitation agency for a climate change leadership program.
