Potential Projects and Programs for Renewable Energy	<ul> <li>a) Ross Irving reported that Sustainability Victoria has identified Ballarat as a key region for development of community renewable energy projects. There will be opportunities to have funding for business cases for renewable energy projects.</li> <li>b) Tim Reported that DELWP Regional Partnerships Program is conducting engagement at 9 locations in the state this month. It provides an opportunity for the Department to get in get in touch with community. Tonight a regional assembly with politicians and senior managers will consider ideas and priorities and consider ideas. Jennifer Ganstchehas been appointed for this role who has interests in agriculture and sustainability.</li> <li>c) Lawrence reported that Cultivate Agribusiness has about \$10 k funds from last (VBN) Ballarat Bioenergy event and are considering the link between biomass waste, rural economies and agriculture. Discussion led top conclusion that the interface between bioenergy, solar, hot water, batteries and technologies. 4. Information Sharing	<ul> <li>a) Andrew Lang commented that European biomass power policies considered impacts of subsidies and impacts of GFC. A Feasibility done on potential uses of straw by Pyrenees and Ballarat e.g. Biomass heating and straw to ethanol. Andrew's Spain visit saw solar towers that have been in operation for many years, and they are interested in sites in Australian</li> <li>b) Community Fire Network finished activities for this season. 4 clusters established, invitations to residents, Facebook established, 31 residents came 3100 visited web pages. Neighbourhood risk assessments done. Foundation established that can be built on in future years.</li> <li>c) Craig reported that Fed Uni has received an Australian public sector procurement award and is a finalist in green gown awards, university sustainability award reducing energy consumption by 17 %,. PRME principles of responsible management awards for Business school. Held international</li> </ul>

Fed Uni is working to enhance the sustainable responsible business elements in the awards. d) Tim Hudspith reported that policy changes are happening in DELWP climate change package including climate change framework and adaptation plan and outcomes of pledges and Implementation outcomes. e) Belinda reported that the City of Ballarat has signed the Take Two pledge. BCC have signed on to a project for low income residents to have access to sustainability improvements to homes. A Solar project at the Phoenix Building is being undertaken. f) GCCWRRG Implementation Plan draft consultation feedback completed and draft has been integrated with other regional plans and new to be submitted to Minister. g) Lawrence commented that Cultivate Agribusiness is involved with the Future Landscapes Project with Hepburn, Pyrenees, Ballarat and Golden Plains Councils to model how landscapes will change under climate change. Modelling with forestry and range of crops to equate where we can grow now and where they will grow in 50 years. To be launched this week. h) Ross SV reported that the Community Energy Guide has been released by SV. Query about community retailer opportunities like NSW could this happen in a Ballarat.  The members discussed RSA's potential to represent the region and engage with politicians.
